GDPR REQUIREMENTS

The European Union's General Data Protection Regulation (GDPR), which went into effect on May 25, 2018, is destined to reshape the way organizations approach data privacy. Critical requirements of GDPR demand that organizations, whether they are the controller or processor of data, implement appropriate technical and organizational measures to:

- Ensure the ongoing confidentiality, integrity, availability, and resilience of processing systems and services
- Restore the availability and access to personal data in a timely manner in the event of a physical or technical incident
- Demonstrate processes for regularly testing, assessing, and evaluating the effectiveness of these measures for ensuring the security of the processing

Digital business has led to a more complex enterprise IT infrastructure that includes physical, virtual, and cloud infrastructure encompassing mobile, distributed, and mainframe computing resources.
